No agency records responsive to your request were identified. BPA's Federal Hydro Projects Operations reports that the sixth HOT Team Actions of an inventory of optimization

tools/techniques to be deployed at each USACE plant/unit is currently only a request/suggestion to be developed. At this date, no documentation or inventory list has been developed.

**Certification**

**Appeal**

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal to [OHA.filings@hq.doe.gov](mailto:OHA.filings@hq.doe.gov), including the phrase "Freedom of Information Appeal" in the subject line. The appeal must contain all of the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter.

Thereafter, judicial review will be available to you in the Federal District Court either: 1) in the district where you reside; 2) where you have your principal place of business; 3) where DOE's records are situated; or 4) in the District of Columbia.
